#### **ELIGIBILITY:**

The scholarship competition is open to high school seniors and recent high school graduates who will not have completed more than one year of college by September of 2012.

- An applicant must not have graduated from high school before 2011.
- An applicant must be a child of an active uniformed union member of the New York State Professional Fire Fighters Association.
- Members of the Executive board or employees of the New York State Professional Fire Fighters Associations children are not eligible.

#### **ANNOUNCEMENT OF WINNERS:**

Scholarship winners will be announced at the 74th Annual Convention of the NYSPFFA in Corning, NY July 9-12, 2012.

#### **AWARDS:**

Awards are made when the recipient has registered at an accredited Undergraduate college as a full time student or any school furthering education beyond high school.

#### **AMOUNT:**

An award of \$1,000 is given to the students selected.

#### **COLLEGE ENTRANCE EXAMS:**

Applicants will be required to take the SAT or ACT test. Students must have taken this examination no later than January of 2012.
