SALARY: The starting salary is \$32,562 annually.

VACANCIES: The Eligible List resulting from this examination will be used to fill any appropriate vacancies that may occur in this title during the life of the list.

Candidates must have been legal residents of Steuben County or one of the RESIDENCY REQUIREMENT: counties contiguous to Steuben in New York State (Allegany, Chemung, Livingston, Ontario, Schuyler, and Yates) for at least four months immediately preceding the date of the written examination.

A non-resident of the City of Hornell who is appointed may be required to become a city resident in accordance with the City Residence Law.

MINIMUM QUALIFICATIONS: POSSESSION OF THE MINIMUM QUALIFICATIONS MUST BE CLEARLY DEMONSTRATED ON YOUR APPLICATION. Graduation from high school or possession of an equivalency diploma

## SPECIAL REQUIREMENT(S):

- 1. Appointees will be required to meet height, weight, and physical standards prescribed by the Municipal Training Council at time of appointment.
- 2. Appointees must possess valid Emergency Medical Technician certification with Defibrillators at time of permanent appointment and maintain it for duration of appointment.
- 3. Appointees must possess a valid New York State Motor Vehicle Operator's License at time of permanent appointment and maintain it for duration of appointment.
- 4. Appointees are required to successfully complete the New York State Office of Fire Prevention and Control Basic Firefighter Training Program, including the physical ability training, within the first year of appointment.



<u>DISTINGUISHING FEATURES OF THE CLASS</u>: This is standardized manual work of a hazardous nature involving fighting fires, performing salvage work in the line of fighting fires, performing general rescue work, performing as a certified EMT during firefighting and other potentially hazardous rescue situations, operating ambulances as a qualified EMT/rescue worker, and responding to requests for emergency assistance. Work is performed under the immediate supervision of a superior officer. Duties also include performing code enforcement inspections on commercial and residential properties, conducting general fire prevention efforts, and conducting routine maintenance and repair work on buildings and fire, ambulance, and rescue equipment under general supervision. Does related work as required.

SUBJECTS OF EXAMINATION: A written test designed to evaluate knowledge, skills, and/or abilities in the following areas:

## 1. Ability to learn and apply information

These questions test for the ability to learn new information and apply it to answer questions effectively. Candidates will read information presented in a Training Lesson and then answer questions regarding the information and procedures covered in the Training Lesson. All information needed to answer the questions will be provided in the Training Lesson, and candidates will be able to refer to the Training Lesson when answering the questions. Some of the questions may require candidates to combine information from different portions of what has been learned in the Training Lesson. No prior knowledge of any specific job or subject matter is needed.

#### 2. Basic arithmetic

This section requires candidates to use basic arithmetic (add, subtract, multiply, divide) to find a missing value in a table of numbers. Candidates will not need to refer to the Training Lesson or any other section of the test to answer the questions in this section. All information needed to answer each question will be contained in this section. No knowledge of firefighting or any other job is required. Candidates should bring a hand-held battery- or solar-powered calculator for use on this test. Candidates will not be permitted to use the calculator function on their cell phone.

## 3. Reading comprehension

These questions test for the ability to understand written materials (e.g., sentences, passages) and answer questions about the information presented. Candidates will be provided with reading passages, followed by questions related to each passage. Each question will require candidates to demonstrate that they have read and understood the information contained in the passage.

## 4. Situational judgment

This section tests for the ability to identify appropriate and effective responses to work-related challenges. Candidates will be presented with several scenarios that reflect the types of challenges one could encounter in a work environment. They will then be asked to rate the effectiveness of a number of possible responses to each scenario.

Candidates are RECOMMENDED to use quiet, hand-held, solar or battery powered calculators.

### \$25 APPLICATION FEE: NO CASH ACCEPTED.

The New York State Civil Service Law requires our Office to collect an application fee. The amount of the fee is **twenty-five dollars** (\$25) per applicant for EACH examination applied for. Fee must be submitted with the application form, by check (personal or certified) or money order, payable to "<u>Steuben County Finance</u>." Applications submitted with postdated checks will be disapproved. You must record the EXAMINATION NUMBER(S) and TITLE(S) on your CHECK.

**NO REFUNDS:** No refund will be made to applicants who are <u>disapproved</u> or who <u>fail to appear</u> to the examination. Applicants whose application forms are not accompanied by the appropriate fee or whose personal checks are returned for insufficient funds will not be considered as candidates.

You are urged to compare your qualifications carefully with the requirements for admission and file only for those examinations for which you are *clearly qualified*. Assistance is available from our office in person or by telephone at 607-664-2345.



MULTIPLE EXAMINATIONS SCHEDULED FOR THE SAME DAY: If you have applied to take a written test announced by either one or several local jurisdictions (county, town, city) scheduled to be held on the same test date as this written test, you must notify each of the local jurisdictions no later than two weeks before the test date, so they can make arrangements for taking all tests at one test site. All examinations for positions in State government will be held at a State examination center.

#### **GENERAL INSTRUCTIONS:**

- 1. Applications and additional information are available at the Steuben County Department of Personnel and Civil Service, Steuben County Office Building, 3 East Pulteney Square, Bath, New York 14810, or by calling 607-664-2345. Examination announcements are also available on the Internet at www.steubencony.org.
- 2. Applications postmarked after midnight of the "Last Filing Date" will be disapproved for this examination. If hand delivered, applications must be filed in the Steuben County Department of Personnel and Civil Service no later than 5:00 p.m. on the "Last Filing Date."
- 3. Falsification of any part of the "Application for Employment" will result in disqualification and possible legal action. Inquiries may be made as to character and ability and all statements made by candidates are subject to verification.
- 4. Applicants must **answer every question** on the application form and provide an **original signature**. You may include a resume in addition to completing the application form; however, you may <u>NOT</u> substitute "See Resume" for completing any portion of the application form. **INCOMPLETE APPLICATIONS WILL BE DISAPPROVED.**
- 5. Be sure to KEEP A COPY of your application materials. The Department of Personnel and Civil Service does <u>not</u> provide copies of records you submit.
- 6. APPLICATION FEE WAIVER: A waiver of the application fee will be allowed if you are unemployed and <u>primarily</u> responsible for the support of a household. In addition, a waiver of the application fee will be allowed if you are determined eligible for Medicaid; receiving Supplemental Security Income payments or Public Assistance (Temporary Assistance for Needy Families/Family Assistance or Safety Net Assistance); or are certified Job Training Partnership Act/Workforce Investment Act eligible through a State or local social service agency. All claims for application fee waiver are <u>SUBJECT TO VERIFICATION</u>. If you can verify eligibility for an application fee waiver, complete Application Item #13.
- Accepted candidates will be notified of when and where to appear for the exam approximately one week before the scheduled date
  of the exam. None will be admitted to the examination without the official admission notice. If an application is disapproved, due
  notice will be sent.
- 8. This department does not make formal acknowledgment of the receipt of an application.
- 9. If you have not received your notice to appear for the exam by three days before the exam date, call 607-664-2345.
- 10. TESTING ACCOMMODATIONS: If special arrangements for testing are required (i.e. religious observance, disability, temporary disability conditions), submit a written request describing your needs with the application form. See Application item #12.
- 11. INTERVIEW ACCOMMODATIONS: If special arrangements for interviewing are required (i.e. disability, temporary disability conditions), submit a written request describing your needs with the application form. See Application item #12.
- 12. VETERANS CREDITS: Active service members, veterans or disabled veterans desiring to claim additional credit may submit an "Application for Veteran's Credit" accompanied by the form DD-214 prior to the establishment of the eligible list. The Form DD-214 may be submitted with your application for examination or at any time prior to the establishment of the resulting eligible list. IT IS YOUR RESPONSIBILITY TO SEE THAT THE FORM DD-214 IS SUBMITTED TO THIS OFFICE. FAILURE TO SUBMIT A COPY OF YOUR DD-214 TO THIS OFFICE PRIOR TO THE ESTABLISHMENT OF ANY ELIGIBLE LIST WILL RESULT IN NO ADDITIONAL CREDIT BEING GRANTED.
- 13. Military Service members on active duty on the exam date may request a military makeup exam by calling 607-664-2345. Members on active duty or discharged during the exam filing period may apply for the exam up to ten days before the exam date.
- 14. Per Section 85-a of the Civil Service Law, children of firefighters and police officers killed in the line of duty are entitled to receive ten additional credits on an exam which may result in an original appointment in the municipality where the deceased parent served. Candidates eligible for additional credit should indicate this on their exam application.
- 15. Candidates who fail the examination or who fail to appear for the examination as scheduled will be eliminated from further consideration.
- 16. Under specific circumstances, an alternate test date may be arranged in accordance with established policy. Your request and <u>verifiable documentation</u> should be submitted at least one week prior to the test date or *in case of an emergency no later than 5:00* <u>p.m. on the next business day</u> following the test. See Application item #12.
- 17. This examination is being prepared and rated by the New York State Department of Civil Service in accordance with Section 23-2 of the Civil Service law. The provision of the New York State Civil Service Rules and Regulations dealing with the rating of exams will apply to this examination.

- 18. Special Requirement for Appointment in School Districts and BOCES: Per Chapter 180 of the Laws of 2000, and by Regulations of the Commissioner of Education, to be employed in a position designated by a school district or BOCES as involving direct contact with students, a clearance for employment from the State Education Department is required.
- 19. Your degree and/or college credits must have been awarded by a regionally-accredited college or university or one recognized by the New York State Education Department as following acceptable educational practices. If an educational institution outside of the United States and its territories awarded your degree and/or college credit you must provide independent verification of equivalency. You can call or write to our Department for a list of acceptable companies providing this service; you must pay the required evaluation fee.
- 20. Unless otherwise noted, candidates are recommended to use quiet, hand-held, solar or battery powered calculators. Devices with typewriter keyboards, Spell Checkers, Personal Digital Assistants, Address Books, Language Translators, Dictionaries, or any similar devices are prohibited. You will not be permitted to use the calculator function of a cell phone.
